

#### G How we do it

We host an annual event that presents a forum for stakeholders and policy actors to deliberate and discuss pertinent issues related to the Illicit Financial Flows (IFFs) agenda. Through this event, participants gain access to cutting-edge research, insightful analysis from experts, and thought-provoking discussions on the most pressing issues facing Africa's tax justice movement. The event also provides a space for participants to share knowledge, experiences, best practices in addressing IFFs, network and build partnerships that can help advance the fight against IFFs and tax injustice in Africa.



PAC is organised into various types of sessions, including workshops, plenary sessions, and panel discussions with opportunities for networking and engaging in interactive sessions with key stakeholders in the field of tax justice.



#### Where we are

The Pan-African Conference on illicit financial flows and taxation (PAC) has grown to become a recognised forum for policymakers, tax experts, civil society organisations, journalists, and other stakeholders involved in discussing and developing solutions to the issue of illicit financial flows in Africa.

In 2022, the PAC event held in Lusaka, Zambia attracted an attendance of 300 participants from 21 African countries. This success is a testament to the growing recognition of the importance of addressing illicit financial flows in Africa and the critical role that the PAC plays in achieving this goal.
